Subject: The Pennsylvania Doctors of Naturopathy Regulation Act

This is a very poorly written law that does not confirm with the Constitutions and rules of law. It should either be rescinded or revised. What went on with COVID and the forced administration of vaccines, using the threat to rescind licenses and not allow individual medical practitioners as well as individuals to make their own decisions regarding their own safety and welfare, can cause the government to commit injury to We The People.

Add to this the cost of administration which, by one estimate is \$250,000. Let's say we have 25 naturopathic practitioners which meet the registration standards of 3,000 hours in Naturopathy and 1500 hours of internship. The cost of administration per practitioner is \$10,000, but even with 50 practitioner's it would be \$5,000. Due to the cost of administration, practitioners would either pass those costs on to their clients and/or the state would bear part of the administrative cost, or they would just cease providing these services.

Therefore it would be better to pass this cost to the organizations administering the exams and allow the public to utilize the registration of both naturopathic bodies and eliminate registration. Registration will only raise the cost of providing the public with this service and severely restrict the number of practitioners providing the service, primarily to one select group, while excluding other practitioners who have been providing naturopathic services for decades, but have received their training from other institutions.

Pennsylvania Constitution, Article I Section 2: Political Powers

"All power is inherent in the people, and all free governments are founded on their authority and instituted for their peace, safety and happiness. For the advancement of these ends they have at all times ends they have at all times and inalienable and indefeasible right to alter, reform or abolish their government in such manner as they may think proper."

Virginia Constitution, Test of Preamble:

A DECLARATION OF RIGHTS made by the good people of Virginia in the exercise of their sovereign powers, which rights do pertain to them and their posterity, and the basis and formation of government.

Test of Section 1:

Equality and Rights of Men

That all men are by nature equally free and independent and have certain inherent rights, of which, when they enter into a state of society, they cannot, by any compact, deprive or divest their posterity, namely, the enjoyment of life and liberty, with the means of acquiring and possessing property and pursuing and obtaining happiness and safety.

Text of Section 2:

People The Source of Power

That all power is vested in, and consequently derived from, The People, that magistrates are their trustees and servants, and at all times amenable to them.

Text of Section 3

Government Instituted for Common Benefit

That government is, or ought to be instituted for the common benefit, protection, and security of the people, nation, or community, of all the various modes and forms of government, that is best which is capable of producing the greatest degree of happiness and safety, and is most effectively secured against the danger of maladministration, and whenever any government shall be found inadequate or contrary to those purposes a majority of the community hath an indubitable, inalienable, and indefensible right to reform, alter, or abolish it in such manner as shall be judged most conducive to the public will.

Maxim of Law: Possession

Maxim of Law: Right and Wrong

An error not resisted is approved.

Maxim of Law: Witnesses and Proof

The burden of proof lies upon him who affirms, not on him who denies. Upon the one alleging, not upon him denying, rests the duty of proving.

The necessity of proving lies with him who makes the charge.

Negative facts are not proof.

Maxim of Law: Authority

A delegated power cannot be again delegated.

Where there is no authority for establishing a rule, there is no necessity of obeying it.

(Traditional Naturopaths are not covered by Pennsylvania's Naturopathic Doctor registration Act. (Act of November 3, 2016 P.L. 007, No. 128 and do not register with The State Board of Medicine.).

The law requires, not conjecture, but certainty.

There must be sufficient positive facts proved to take a matter out of the realm of conjecture and presumption to that of certainty.
