Thank you for sharing the proposed regulations-#16A-66 with us here at the Pennsylvania Society of Health-System Pharmacists (PSHP). From our perspectives the contents for consideration of what is defined and covered as "Considerations of Criminal Convictions" requires no discussion and we agree with the proposed regulations.

What we suggest however under – Bureau of Professional and Occupational Affairs, 49 Pa. Code CH. 43b.443 Schedule of criminal convictions – State Board of Pharmacy

We believe that under 43b.404 – Consideration of criminal convictions:

(d) Drug Trafficking Offenses:

(2) This subsection applies to the following licensing board with the Bureau:

(ix) – The State Board of Pharmacy under sections 3(a) and 3.3(a) and (b) of the

Pharmacy act (63 P.S.

(ix) The State Board of Pharmacy under sections 3(a) and 3.3(a) and (b) of the

Pharmacy Act (63 P.S. §§ 390-3(a) and 3.3(a) and (b)), pertaining to qualifications

for licensure as a pharmacist and qualifications for pharmacy technician and

pharmacy technician trainee registration.

The statute above included Pharmacists, pharmacy technician and pharmacy technician trainee registration – AND

## should also include pharmacy interns and their registration process.
