## **RADIATION EMERGENCY RESPONSE FUND**

### AUGUST 20, 1998

We have reviewed this proposed regulation from the Pennsylvania Emergency Management Agency (PEMA) and submit for your consideration the following objections and recommendations. Subsections 5.1(h) and 5.1(i) of the Regulatory Review Act (71 P.S. §§ 745.5a(h) and (i)) specify the criteria the Commission must employ to determine whether a regulation is in the public interest. In applying these criteria, our Comments address issues that relate to clarity. We recommend that these Comments be carefully considered as you prepare the final-form regulation.

## 1. Section 116.4. Allocation of funds. - Clarity.

This section uses the terms "eligible state agencies" and "eligible risk and support counties." The definitions for the terms "state agency," "risk county" and "support county" are included in Section 116.1. However, there is no definition that includes the term "eligible." Program requirements and eligible expenditures are set forth in Section 116.5. Subsection 116.5(a)(1) reads:

In order to maintain eligibility for funding, each county, risk municipality, school district, volunteer organization, and State Agency shall meet the requirements of the Agency's [PEMA] Radiation Emergency Response Program.

Subsection 116.5(a)(2) sets forth the requirements of PEMA's Radiation Emergency Response Program. We recommend that Section 116.4 include a reference to Section 116.5 to provide the reader with information concerning the requirements for eligibility.

## 2. Section 116.6. Application and review procedures for funding. - Clarity.

The proposed regulation deletes language in Subsection 116.6(c) that states PEMA will provide application forms and includes a four-part list of information to be included in the application forms. The language is being deleted because the list is out-dated and is constantly being updated or revised. However, PEMA will continue to provide applicants with these forms.

We recommend that the regulation retain a sentence that states the requisite application forms will be provided by PEMA. This eliminates the problem of maintaining an accurate list of application information in the regulation while notifying readers that PEMA will provide them with the necessary forms.
