State Real Estate Commission
General Revisions

On January 20, 1999, the Independent Regulatory Review Commission (Commission) received this proposed regulation from the State Real Estate Commission. This rulemaking amends 49 Pa. Code Chapter 35. The proposed regulation was published in the January 30, 1999 *Pennsylvania Bulletin* with a 30-day public comment period. The final-form regulation was submitted to the Commission on September 25, 2000.

The final-form regulation requires candidates for the broker's examination to demonstrate completion of courses in real estate office management and real estate law, as well as 12 credits in other real estate courses. Additionally, real estate companies that have an ownership interest in a real estate school, college, university or institute of higher learning must disclose that interest in all advertisements, promotions and endorsements.

We have determined this regulation is consistent with the statutory authority of the State Real Estate Commission (63 P.S. §§ 455.404 and 455.602) and the intention of the General Assembly. Having considered all of the other criteria of the Regulatory Review Act, we find promulgation of this regulation is in the public interest.
