BY ORDER OF THE COMMISSION

On July 28, 1999, the Independent Regulatory Review Commission (Commission) received this proposed regulation from the State Real Estate Commission (Commission). This rulemaking amends 49 Pa. Code Section 35.203. The authority for this regulation is Section 407(a) of the Real Estate Licensing and Registration Act (63 P.S. § 455.407(a)). The proposed regulation was published in the August 7, 1999 Pennsylvania Bulletin with a 30-day public comment period. The final-form regulation was submitted to the Commission on April 6, 2000.

The regulation revises 19 existing fees and adds two new fees. The Board estimates that 11,380 persons will avail themselves of one or more of the enumerated services over the next two-year period. Total additional costs to the regulated community during that time span will be approximately \$397,255. Only those requesting the enumerated services will be affected.

This regulation meets the criteria of the Regulatory Review Act.

THEREFORE, IT IS ORDERED THAT:

- 1. Regulation No. 16A-566 from the State Real Estate Commission, as submitted to the Commission on April 6, 2000, is approved; and
