Department of Agriculture
Importation and Intrastate Transportation of
Animals; Brucellosis

On January 31, 2000, the Independent Regulatory Review Commission (Commission) received this proposed regulation from the Department of Agriculture (Department). This rulemaking amends 7 Pa. Code Chapters 3 and 7. The proposed regulation was published in the February 12, 2000 Pennsylvania Bulletin with a 30-day public comment period. The final-form regulation was submitted to the Commission on September 14, 2000. On September 27, 2000, the Commission received a request from the Department to toll consideration of this final-form regulation to correct minor technical problems. On October 4, 2000, the Department of Agriculture submitted its revisions to the final-form regulation to the Commission.

This regulation updates the Department's vaccination requirements for Brucellosis in cattle and bison and acceptable testing requirements for Equine Infectious Anemia in horses. The revisions also raise the age allowable for an official vaccination for Brucellosis from 8 months to 12 months and clarifies identification of calves by a change in tattoo requirements.

We have determined this regulation is consistent with the statutory authority of the Department of Agriculture (3 Pa. C.S. §§ 2301-2389) and the intention of the General Assembly. Having considered all of the other criteria of the Regulatory Review Act, we find promulgation of this regulation is in the public interest.

BY ORDER OF THE COMMISSION:

This regulation is approved.
