## **Regulation 16A-644**

### **State Board of Auctioneer Examiners**

**PROPOSAL:** Regulation 16A-644 amends 49 PA Code, Chapter 1, regulations of the State Board of Auctioneer Examiners. The amendment makes revisions to the schedule of Board fees by adding six new fees for services for which there is currently no charge.

The proposed Rulemaking was published in the <u>Pennsylvania Bulletin</u> on May 6, 2000. The Professional Licensure Committee has until June 26, 2000, to submit comments on the regulation.

**ANALYSIS:** Pursuant to Sec. 6(a) of the Auctioneer and Auction Licensing Act, 63 P.S. Sec. 734.6(a), the Board is required to meet expenditures through revenues raised by fees, fines and civil penalties. The Board proposes to establish six new fees identified in a recent audit as attributable to requests by licensees for services or Board approval or action as required by the act or regulation:
