Dear Mr. Markham:

We represent the Pennsylvania Catholic Conference, the public affairs agency of the Catholic dioceses in Pennsylvania. The Conference's constituent dioceses and the parishes located therein operate substantial numbers of elementary and secondary schools, as well as child care facilities that are supervised by the Department of Public Welfare.

The Conference seeks one clarification in the applicability of the requirements for the reporting of communicable diseases which the Department of Health proposes to adopt under 28 Pa. Code §27.23. Those requirements purport to attach to "child care group settings," a term defined in §27.1 to broadly include care provided to 4 or more children. Elsewhere in the proposed regulations, the Department does distinguish between "schools" and "child care group settings." See, e.g., §§27.71, et seq. Catholic schools therefore need to know specifically whether they will be subject to the reporting requirements of §27.23, or whether those requirements apply solely to those child care facilities falling under the supervisory jurisdiction of the Department of Public Welfare.

We would very much appreciate a clarification in the text of the proposed regulations on this rather significant issue of coverage.
