Reporting of Communicable and

On May 17, 2000, the Independent Regulatory Review Commission (Commission) received this proposed regulation from the Department of Health. This rulemaking amends 28 Pa. Code, Chapters 27 and 211. The proposed regulation was published in the May 27, 2000 *Pennsylvania Bulletin* with a 30-day public comment period. The final-form regulation was submitted to the Commission on November 26, 2001.

This rulemaking updates the existing reporting system for disease prevention and control within Pennsylvania. These amendments will affect numerous types, including: health care providers, health care practitioners, health care facilities, clinical laboratories and child care group settings.

We have determined this regulation is consistent with the statutory authority of the Department of Health (35 P.S. §§ 521.16(a)) and the intention of the General Assembly. Having considered all of the other criteria of the Regulatory Review Act, we find promulgation of this regulation is in the public interest.
