## Regulation 16A-7011

## **State Board of Certified Real Estate Appraisers**

**PROPOSAL:** Regulation 16A-7011 amends 49 PA Code, Chapter 36, regulations of the State Board of Certified Real Estate Appraisers. The amendment makes revisions to the schedule of Board fees by increasing the fees for certain services provided by the Board.

The proposed Rulemaking was published in the <u>Pennsylvania Bulletin</u> on October 14, 2000. The Professional Licensure Committee has until December 3, 2000 to submit comments on the regulation.

ANALYSIS: Pursuant to Sec. 5(6) of the Real Estate Appraisers Certification Act, 63 P.S. Sec. 457.5(6), the Board is required to meet expenditures through revenues raised by fees, fines and civil penalties. The Board is required to increase fees so that projected revenues will meet or exceed projected expenditures. Fees for various services provided directly to applicants or licensees are based upon the actual charge of providing the service requested. The Board states that the following fees would be changed to reflect the actual cost of providing the service:
