# **Fees for Board Services**

## February 22, 2001

We submit for your consideration the following objections and recommendations regarding this regulation. Each objection or recommendation includes a reference to the criteria in the Regulatory Review Act (71 P.S. § 745.5a(h) and (i)) which have not been met. The State Board of Certified Real Estate Appraisers (Board) must respond to these Comments when it submits the final-form regulation. If the final-form regulation is not delivered by November 13, 2002, the regulation will be deemed withdrawn.

#### 1. General. - Clarity.

#### Fee Report form

The fee report form and the preamble both state that the new fee for "Application for Approval as Continuing Education Provider" will be \$85 while the fee in the proposed regulation is \$55. The fee in the regulation should be changed from \$55 to \$85 to reflect the correct fee.

## 2. Section 36.6. - Fees. - Reasonableness; Clarity.

Application by examination Application by reciprocity

The House Professional Licensure Committee has suggested, and we agree, that the fee categories of "application by examination" and "application by reciprocity" could give the impression that there are two different exam fees. To alleviate this confusion, the fee categories should be changed to "licensure application fee" and "licensure by reciprocity."

# Application for certification as appraiser by examination Application for certification as certified Pennsylvania evaluator

The application fees for certification as a real estate appraiser and as a Pennsylvania evaluator have increased by more than 200%. By what percentage has the Board's operating costs increased? The Board should explain the reason for the substantial increase of the fees for these two applications.

#### Continuing education provider

The category of "continuing education provider" should be plural to be consistent with the other listed categories.
