Department of State
UCC Fees

On June 26, 2001, the Independent Regulatory Review Commission (Commission) received this regulation from the Department of State (Department). This rulemaking amends 19 Pa. Code § 3.30. Notice of proposed rulemaking was omitted for this regulation; it will become effective upon publication in the *Pennsylvania Bulletin*.

This rulemaking changes the Uniform Commercial Code fees for filing financing statements, charged by the Department of State and the county recorder of deeds offices. The revised fee amounts are \$84.00 for a financing statement filed with the Department and \$95.00 for a financing statement filed with a county recorder of deeds office. These revised fees have been established to generate revenue equal to the amounts collected by the Department and the counties, as required by Act 18 of 2001.

We have determined this regulation is consistent with the statutory authority of the Department (Act 18 of 2001) and the intention of the General Assembly. Having considered all of the other criteria of the Regulatory Review Act, we find promulgation of this regulation is in the public interest.
