Dear Mr. McGinley:

We are writing to you concerning the final rulemaking pertaining to Chapter 449, Liquid Fuels Tax Funds. The amended regulations will update and revise existing provisions of Chapter 449 in order bring the regulations into compliance with statutory requirements passed in 1990. We have reviewed the proposed final regulations and have the following comments.

Section 449.7 (d) is amended to require that the "estimates for materials between \$4,000 and \$10,000 have three telephone price quotes". This change would put the regulation in conformity with the statute. Our concern is the requirement that if three quotations are not available due to the fact that fewer than three qualified contractors service the market area, "...a memorandum shall be kept on file showing..." the inability to comply. It does not state how long this memorandum must be kept and it implies that it is a permanent document, which when the suggestion of the suggestion of the showing that fewer...."

Section 449.7 (e) proposes allow municipalities to "piggyback" purchases not only from the Department of Gene. I Services but also "intergovernmental agencies." Although we can agree with the intent of the provision, we have concerns with the wording. As written, it implies that intergovernmental agencies would be able to acquire materials and services without compliance with following the requirements of the 1990 acts. We suggest the section be rewritten to read:

(e) Purchases through Department of General Services or intergovernmental agencies. Advertising, bidding and bonding requirements shall not apply to "piggyback" purchases from suppliers under contracts with the Department of General Services for intergovernmental agencies. Intergovernmental agencies that comply with the advertising, bidding and bonding requirements shall relieve a municipality cooperating in the purchasing agreement from compliance with the advertising, bidding and bonding requirements.
