I am writing to briefly comment on the Department of Labor & Industry's Finalform regulation governing appeals to the Unemployment Compensation Board of Review.

On the whole, I believe the proposed regulations are a step in the right direction. Unquestionably, the regulations need to be updated to reflect the vast changes in the way an individual can now communicate and transmit information. By providing additional means for parties to file appeals, the Department is assisting both claimants and employers, and the Department should be applauded for its efforts.

I believe it is essential that we keep in mind that though a majority of individuals have no problem in filing appeals, there are some who do have difficulty navigating the UC system because of barriers such as a limited ability to speak and read the English language. In order to ensure that those individuals do not lose any of their rights under the law, we must do whatever possible to make the process work for them. In that vein, I do concur with several of the comments made by Sharon Dietrich of Community Legal Services in her August 6th letter to the IRRC.

In conclusion, I would like to urge the Department to undertake a long term review of all unemployment compensation regulations in order to bring them into line
