Amending §203.11 to include sections (4.1) and (6.1) will benefit the public interest by requiring municipal police officers to be literate and physically fit, thus enabling them to better perform their duties.

Amending §203.12(4) will ensure that all municipal police officers will have current training upon certification.

Amending §203.33(a)(14) clarifies and insures that schools authorized to train municipal police officers will have adequate firing ranges available for firearms training and allows for indoor firing ranges.

Amending §203.54(a) clarifies the rules on cheating during training. This is intended to benefit the public by maintaining the integrity of the municipal police training programs.

Certified police training schools will benefit by being able to use an indoor firing range in the training.

Waiver applicants that are unable to pass the certification examination in three attempts will have to re-take the entire basic training course. The number of persons affected is hard to quantify, but presumably the changes would not affect the majority of applicants.

Municipal police officers, certain campus police officers, certain deputy sheriffs, trainees, municipalities and certified police training schools. Approximately 50 to 100 officers will be affected annually. Certified police training schools will also be affected.

The proposed changes to the existing regulations have been discussed and voted upon at various and numerous public meetings of the Commission.

MUNICIPAL POLICE OFFICERS' EDUCATION AND TRAINING COMMISSION

[37 PA. CODE CH. 203]

Administration of the Training Program

Description and Purpose

The Pennsylvania State Police, Municipal Police Officers' Education and Training Commission (Commission), proposes to amend 37 Pa. Code §203.11(4.1) & (6.1) (relating to qualifications) to include a ninth grade reading requirement and a physical fitness evaluation.

The Commission proposes to amend 37 Pa. Code §203.12(4) (relating to waiver of training) to limit a waiver candidate to three attempts at passing the Commission's certification examination. After the third failure, the candidate must re-take and pass the entire basic training course before that person will be eligible for certification. This amendment will ensure that a waiver candidate has current training by limiting the amount of times that the certification examination can be taken.

The Commission proposes to amend 37 Pa. Code §203.33(a)(14) (relating to minimum school standards) to allow certified schools to use indoor ranges, and to insure that all ranges must be able to handle the required training.

The Commission also proposes to amend its policy on cheating in order to define and clarify the acts that will constitute cheating and to make clear that anyone found guilty of cheating will be ineligible for certification.

The purpose of these proposed amendments is to clarify and correct various aspects of the existing regulations. The proposals are set forth in Annex A.

Statutory Authority

The amendments are proposed pursuant to 53 Pa.C.S. §2164 (1), (8), & (14) (relating to Part III, Subpart C, of the Local Government Code).

Effect

The proposed changes will primarily affect recruits. Recruits will have to pass a physical fitness assessment and pass a ninth grade reading test before they can become eligible for training.

January 8, 2003

The amendments will impact those persons seeking waivers of training, since they will have only three opportunities to successfully pass the certification examination. After the third failure, the waiver candidate must re-take and pass the basic training course in order to become eligible for certification.

Both recruits and veteran police officers will be affected by the new cheating policy. The impact of the new cheating policy is to put individuals and schools on notice as to what will be considered cheating on an official Commission sponsored examination. This amendment will allow the schools and the students to more readily detect and curb cheating and it establishes a more uniform policy.

Allowing certified schools to use indoor ranges will offer more flexibility to the schools. However, the indoor and outdoor ranges must be able to safely accommodate all of the required training.

Effective Date/Sunset Date

The amendments will be effective immediately upon final adoption. These regulations are continually monitored and updated as needed. Therefore, no sunset date has been set.

Regulatory Review

Under section 5(a) of the Regulatory Review Act, 71 P.S. §745.1 et seq., the Commission submitted a copy of the proposed Annex and a copy of the Regulatory Analysis Form on <u>February 24, 2003</u> to the Independent Regulatory Commission (IRRC) and to the Chairperson of the House Judiciary Committee and the Senate Law and Justice Committee. A copy of these materials are available to the public upon written request.

Under Section 5(g) of the Act, IRRC may convey any comments, recommendations or objections to the proposed Annex within 30 days after the close of the public comment period. The comments, recommendations or objections shall specify the regulatory review criteria which have not been met. The Act specifies detailed procedures for review, prior to final publication of the regulation, by the State Police, the General Assembly and the Governor of comments, recommendations or objections raised.

PART IV. MUNICIPAL POLICE OFFICERS' EDUCATION AND TRAINING COMMISSION

Subpart A. MUNICIPAL POLICE OFFICERS' TRAINING PROGRAM
CHAPTER 203. ADMINISTRATION OF THE TRAINING PROGRAM

203.11 Qualifications

Insert the following language after subsection (5):

(5.1) Be able to read at no less than the ninth grade level, as established through the administration of the NELSON-DENNY READING TEST.

Insert the following language after subsection (5):

(6.1) Be evaluated to determine physical fitness using the standards developed by the Cooper Institute for Aerobics Research in Dallas, Texas. Each applicant shall score no lower than the 30th percentile of the Cooper standards, which coincides with the 30th percentile of the general population, in each of the five required evaluations in order to be eligible for employment. No person will be enrolled in a recruit training program at a police academy certified by the Commission unless the person has obtained a score in the 30th percentile or higher for the person's age and gender as specified in the Cooper standards for each of the five evaluations. The five required evaluations are as follows:

- (a) 1.5 mile run
- (b) 300 meter run
- (c) 1 repetition bench press
- (d) 1 minute sit ups
- (e) sit and reach

203.12 Waiver of training

- (4) Take a certification examination administered by the Commission at a location and time designated by the Commission. The schedule for the examinations may be obtained by writing the Commission office.
- (i) [The examination will be comprised of sections which shall coincide with each major topic in the basic training curriculum, but shall exclude those topics which can be proficiency tested only. See paragraph (3).] [(ii)] The minimum passing score [for each tested section] will be established by the Commission. The Commission will publish a notice in the *Pennsylvania Bulletin* and in the Commission newsletter whenever the minimum passing score [for each tested section] changes.
- [(A)] (ii) An applicant for a waiver of training [who does not achieve a passing score in a tested area shall take the basic police training course corresponding to the failed examination section at a school certified by the Commission, in order to be permitted to retake the certification examination] shall be permitted to take the certification examination a maximum of three times and only once in any day.
- [(B)] (iii) Applicants will not be certified without obtaining a passing score on the certification examination. Failure to pass the certification examination after three attempts shall result in the applicant being required to take and pass the entire basic training course in order to qualify for certification.
- [(iii)] (iv) Examination results shall be valid for 2 years. For applicants obtaining a passing score, no further examinations will be administered within this period.

203.33 Minimum school standards and requirements

(a)(14) An approved [type of outdoor] firing range shall be available to the school and used for firearms training. The range does not have to be part of the school facilities [; however, it shall have at least ten firing points with a minimum firing distance of 50 yards. The range but shall be within a reasonable traveling distance from the school. The range shall be able to accommodate the requirements of the firearms training curriculum. The range shall present no apparent danger to the public as determined by the Commission inspector.

203.54 Commission cheating policy

- (a) The contents of all examinations are confidential. An individual [observed cheating] shall not cheat or tamper in any manner with an official examination either conducted or sponsored by the Commission by obtaining, furnishing, accepting, or attempting to obtain, furnish or accept answers or questions to such examinations, or portions thereof. Furthermore, individuals shall not copy, photograph, or otherwise remove examination contents; nor shall they use any misrepresentation or dishonest method while preparing, administering, or participating in such examinations. Unauthorized possession of any test, examination or quiz or any questions, answers or answer keys relating to any test, examination or quiz shall constitute cheating. An individual violating this regulation shall be barred from further participation in any Commission required training and ineligible for certification. Individuals will receive notice and have an opportunity to be heard under Subchapter G (relating to notice and hearings).

- (1) amend § 203.11(4.1) and (6.1), relating to qualifications, to include a ninth-grade reading requirement and a physical fitness evaluation;
- (2) amend § 203.12(4), relating to waiver of training, to provide that any candidate who obtains a training waiver must pass the certification examination by the third attempt or take and pass the entire basic training course;
- (3) amend § 203.33(a)(14), relating to minimum school standards, to require certified schools to have adequate firing ranges and allow the use of indoor firing ranges; and
- (4) amend the Commission's policy on cheating to define the acts that will constitute cheating and clarify that anyone found guilty of cheating will not be eligible for certification.
