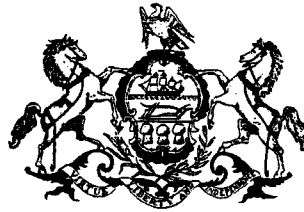

Dear Chairman McGinley:

I am writing to inform you that the House Professional Licensure Committee held a meeting on May 6, 2003.

The Committee voted to approve Regulation 16A-7012, State Board of Certified Real Estate Appraisers.

The Committee voted to take no formal action on Regulation 16A-4811, State Board of Funeral Directors, until final form regulations are promulgated.

The Committee voted to take no formal action on Regulation 16A-5714, State Board of Veterinary Medicine, until final form regulations are promulgated. However, the Committee submits the following comments:

1. The Committee recommends that the proposed amendments incorporate the increase in required continuing education clock hours established with the enactment of Act 167 of 2002.
2. The Committee recommends that the proposed amendments incorporate the change of "certified animal health technician" to "certified veterinary technician" established with the enactment of Act 167 of 2002.

**Regulation 16A-4811**

**State Board of Funeral Directors**

**PROPOSAL:** Regulation 16A-4811 amends 49 PA Code, Chapter 13, regulations of the State Board of Funeral Directors. The amendment makes revisions to the schedule of Board fees by increasing the fees for license renewal.

The proposed Rulemaking was published in the Pennsylvania Bulletin on March 15, 2003.

**ANALYSIS:** Pursuant to Sec. 18.1 of the Funeral Director Law, 63 P.S. Sec. 479.18.1, the Board is required to meet expenditures through revenues raised by fees, fines and civil penalties. The Board is required to increase fees so that projected revenues will meet or exceed projected expenditures. The Board states that the biennial license renewal fee is the most substantial revenue-generating fee charged by the Board, which was last raised in 1992. According to an analysis prepared by the Department of State's Bureau of Finance and Operations, the Board's current biennial renewal fee structure is inadequate to meet the Board's projected revenue needs. A deficit of almost \$26,000 is projected for fiscal year ending June 30, 2003, and a deficit of over \$500,000 for fiscal year ending June 30, 2007. The Board proposes the following increase:

**RECOMMENDATIONS:** It is recommended that the Professional Licensure Committee take no formal action until final form regulations are promulgated.





Renewal Fee



The State Board of Funeral Directors (Board) proposes to amend its regulations at 49 Pa. Code § 13.12 (relating to fees) by raising the biennial renewal fee, as set forth in Annex A.

Effective date

The amendment will be effective upon publication of the final regulation in the *Pennsylvania Bulletin*, beginning with renewal for the 2004-2006 biennial renewal period.

Statutory Authority

The amendment is authorized under section 18.1 of the Funeral Director Law (63 P.S. § 479.18.1).

Background and Need for the Amendment

The Board is required by law to support its operations from revenue it generates from fees, fines and civil penalties and to periodically review its expenditures and revenue streams to assure that revenues meet or exceed expenses. The Board was last required to increase its biennial renewal fees in 1992.

At its March 6, 2002, meeting, the Board reviewed the following summary of its revenues and expenses prepared by the Bureau of Professional and Occupational Affairs Revenue Office and the Bureau of Finance and Operations.

As the chart indicates, a deficit of almost \$26,000 is projected at fiscal year ending June 30, 2003, a deficit of over \$230,000 is projected at fiscal year ending June 30, 2005, and a deficit of over \$500,000 is projected at fiscal year ending June 30, 2007. The Board must generate revenues of about \$1,100,000 to meet its anticipated expenditures in fiscal years 2003-04 and 2004-05, in addition to recovering the anticipated deficit of June 30, 2003.

The Board raises virtually all its revenues through fees. The biennial license renewal fee is the most substantial revenue-generating fee of the fees charged by the Board. Section 18.1(a) of the Funeral Director Law (63 P.S. § 479.18.1(a)) requires the Board to increase fees by regulation if the revenues raised by fees, fines and civil penalties are not sufficient to meet expenditures over a 2-year period.

The Board proposes to begin recovering that deficit during the 2004-06 biennial period. The Board anticipates that the proposed new fees and the increased user fees which have recently been promulgated would enable it to recapture the current deficit, meet its estimated expenditures for the upcoming fiscal years and generate a surplus of approximately \$160,000 at the end of fiscal year 2004-05.

#### Description of the Proposed Amendments

Existing section 13.12 would be amended to increase the biennial renewal fee from \$130 to \$185.

#### Compliance with Executive Order 1996-1

In compliance with Executive Order 1996-1, "Regulatory Review and Promulgation," in drafting and promulgating the proposed amendment, the Board considered the proposed amendment as both required by law and the least restrictive means of covering the costs of services required to be performed by the Board.

#### Fiscal Impact and Paperwork Requirements

The proposed amendment would increase the biennial renewal fee for funeral directors and funeral establishments in this Commonwealth, but, otherwise, should have no adverse fiscal impact on the Commonwealth, its political subdivisions, or the private sector. The amendments will impose no additional paperwork requirements upon the Commonwealth, its political subdivisions, or the private sector.

#### Sunset Date

The Board continuously monitors the cost effectiveness of its regulations. Therefore, no sunset date has been assigned.

### Regulatory Review

Pursuant to section 5(a) of the Regulatory Review Act (71 P.S. § 745.5(a)), the Board submitted a copy of this proposed regulation on March 5, 2003, to the Independent Regulatory Review Commission (IRRC), the Senate Consumer Protection and Professional Licensure Committee (SCP/PLC), and the House Professional Licensure Committee (HPLC). In addition to submitting the regulation, the Board has provided IRRC, SCP/PLC and HPLC with a copy of a detailed regulatory analysis form prepared by the Board in compliance with Executive Order 1996-1, "Regulatory Review and Promulgation." A copy of this material is available to the public upon request.

Under section 5(g) of the Regulatory Review Act (71 P.S. § 745.5(g)), if IRRC has any comments, recommendations or objections regarding any portion of the proposed regulation, it will notify the Board within 30 days after the expiration of the public comment period. Such notification will specify the regulatory review criteria that have not been met. The Regulatory Review Act specifies detailed procedures for review of comments, recommendations and objections by the Board, the General Assembly and the Governor, prior to publication of the regulation.

(8) Briefly explain the regulation in clear and nontechnical language.

The proposed amendment would amend the fee schedule for the State Board of Funeral Directors to revise the biennial renewal fee. The current fee has not been revised since 1992.

(9) State the statutory authority for the regulation and any relevant state or federal court decisions.

The regulatory amendments are adopted under Section 18.1 of the Funeral Director Law, act of January 14, 1952 (P.L. 1951-1898) as amended, 63 P.S. § 479.18.1.

(10) Is the regulation mandated by any federal or state law or court order, or federal regulation? If yes, cite the specific law, case or regulation, and any deadlines for action.

Yes. If revenues generated by fees, together with civil penalties imposed and collected, are not sufficient to match expenditures of a two-year period, Section 18.1 of the Funeral Director Law requires the Board to increase its fees by regulation such that projected revenues will meet or exceed projected expenditures.

## **Regulatory Analysis Form**

(11) Explain the compelling public interest that justifies the regulation. What is the problem it addresses?

**Section 18.1 of the Funeral Director Law requires that the Board set fees by regulation so that revenues meet or exceed expenditures over a biennial period. The Board has recently revised its fees for services to recover the cost of providing those services. The balance of the operating expenses of the Board must be borne by the licensee population through biennial renewal revenue.**

(12) State the public health, safety, environmental or general welfare risks associated with nonregulation.

**Nonregulation could potentially adversely impact the fiscal integrity of the Board. If the renewal fee is not revised, the Board may be financially unable to meet its statutory obligation of public protection.**

(13) Describe who will benefit from the regulation. (Quantify the benefits as completely as possible and approximate the number of people who will benefit.)

**The general public and licensees will benefit from the regulation through the assurance that the Board will remain fiscally sound and able to meet its statutory obligation of public protection.**

(14) Describe who will be adversely affected by the regulation. (Quantify the adverse effects as completely as possible and approximate the number of people who will be adversely affected.)

**Licensees of the Board will be adversely affected by the regulation by having to pay a higher biennial license renewal fee.**

(15) List the persons, groups or entities that will be required to comply with the regulation. (Approximate the number of people who will be required to comply.)

**There are approximately 6510 licensees, whether individual funeral director, funeral supervisor, or funeral home entity. Each licensee will be required to comply with the regulation.**

(16) Describe the communications with and input from the public in the development and drafting of the regulation. List the persons and/or groups who were involved, if applicable.

**Because this amendment does not place requirements on licensees concerning their conduct or compliance with state law regarding the performance of a licensing duty under licensing statutes, but only adjusts the biennial renewal fee, the Board did not seek input from the regulated community.**

(17) Provide a specific estimate of the costs and/or savings to the regulated community associated with compliance, including any legal, accounting or consulting procedures which may be required.

**The Board estimates that the aggregate additional costs for the regulated community will be approximately \$358,050 per biennial renewal period. The Board estimates that there will be no other costs or savings to the regulated community associated with compliance with this regulation.**

(18) Provide a specific estimate of the costs and/or savings to local governments associated with compliance, including any legal, accounting or consulting procedures which may be required.

**There are no costs or savings to local governments associated with compliance with the proposed regulation.**

(19) Provide a specific estimate of the costs and/or savings to state government associated with the implementation of the regulation, including any legal, accounting, or consulting procedures which may be required.

**The Board will process applications for limited licenses and biennial renewals. There are no other costs or savings to state government associated with implementation of the proposed regulation.**

**The biennial renewal fee for each license would increase \$55, from the current \$130 to the proposed \$185. There are approximately 6510 licensees.**

**Because the Board is required by statute to raise its fees to match expenditures, the need to assure fiscal integrity of the Board outweighs the increased cost to the regulated community.**

(22) Describe the nonregulatory alternatives considered and the costs associated with those alternatives. Provide the reasons for their dismissal.

**Because the Act requires the Board to promulgate regulations to set its fees, the Board considered no non-regulatory alternatives.**

(23) Describe alternative regulatory schemes considered and the costs associated with those schemes. Provide the reasons for their dismissal.

**The Board considered no alternative regulatory schemes, because the Funeral Director Law requires the Board to promulgate regulations to change fees.**

**The proposed regulatory amendments do not overlap or conflict with any federal requirements.**

(25) How does this regulation compare with those of other states? Will the regulation put Pennsylvania at a competitive disadvantage with other states?

**Each state licensing agency charges a renewal fee. Maryland charges \$300 for biennial renewal of individual mortician, funeral director, and surviving spouse licenses, and \$400 for biennial renewal of funeral establishment licenses. New Jersey charges \$170 for biennial renewal of individual practitioner, embalmer, and funeral director licenses, and \$350 for biennial renewal of mortuary registrations. New York charges \$50 for biennial renewal of funeral director licenses and \$150 for biennial renewal of funeral firm licenses. Ohio charges \$120 for biennial renewal of embalmer or funeral director licenses and \$250 for biennial renewal of funeral home licenses. West Virginia charges \$30 for annual renewal of embalmer and funeral director licenses and \$125 for annual renewal of funeral establishment licenses.**

**The proposed fee is consistent with fees charged by surrounding states. The proposed regulation will not put Pennsylvania at a competitive disadvantage with these other states.**

(26) Will the regulation affect existing or proposed regulations of the promulgating agency or other state agencies? If yes, explain and provide specific citations.

**This regulation will have no effect on other regulations of the Board or other state agencies.**

(27) Will any public hearings or informational meetings be scheduled? Please provide the dates, times, and locations, if available.

**The Board reviews its regulatory proposals at regularly scheduled public meetings, generally the first Wednesday of each month, at 116 Pine Street in Harrisburg. Dear Chairman McGinley:

I am writing to inform you that the House Professional Licensure Committee held a meeting on November 17, 2003.

The Committee voted to approve Regulation 16A-4912, Final Rulemaking of the State Board of Medicine pertaining to physician delegation of medical services.

The Committee voted to approve Regulation 16A-5115, Final Rulemaking of the State Board of Nursing pertaining to oral orders.

The Committee voted to approve Regulation 16A-497, Final Rulemaking of the State Board of Medicine pertaining to sexual misconduct.

The Committee voted to approve Regulation 16A-539, Final Rulemaking of the State Board of Osteopathic Medicine pertaining to sexual misconduct.

The Committee voted to take no formal action on Regulation 16A-561, Proposed Rulemaking of the State Real Estate Commission pertaining to education until final form regulations are promulgated. However, the Committee submits the following comments:

1. The Committee requests an explanation as to why the Commission proposes eliminating the per-student calculation for determining the amount of the surety bond to be posted by an education provider, and how the Commission determined that a \$10,000 bond sufficiently protect a student's contractual rights. Is a \$10,000 bond adequate when an increase in students can be expected now that distance learning will be permitted?
2. In regard to distance learning, the Committee requests an explanation as to what is involved in the review of delivery systems and examples of delivery systems that have been approved or rejected.
3. The Committee requests an explanation as to why the 21 year old age requirement for ownership of an education provider would be deleted.
4. The Committee requests an explanation as to why the requirement that education provider applicants provide a notarized pro forma profit and loss statement and balance sheet would be deleted.
5. In regard to education providers located in other jurisdictions, the Committee requests an explanation as to how the Commission will conduct inspections and enforce its regulatory requirements pertaining to a provider's facility, director,

instructors, record keeping, etc.. How will the Commission gain access to records and documentation maintained in other jurisdictions?

6. The Committee requests an explanation as to why the Commission proposes to eliminate the requirements as to floor space, illumination, etc.. in provider facilities.
7. The Committee requests an explanation as to why continuing education course transcripts and certificates of instruction will be issued to students only upon request.
8. The Committee requests an explanation as to why "management of real estate brokerage operations" as an acceptable topic for continuing education. Section 404.1(c) of the Act expressly provides that no continuing education credit shall be given for courses in office management.
9. The Committee requests an explanation as to why reference to a misdemeanor involving moral turpitude would be deleted in Sec. 35.344(b)(5). Has approval of an educational provider director ever been withdrawn due to his or her involvement in a crime of moral turpitude?
10. Sec.35.341(4) requires an education provider to designate a person or entity to serve as custodian of records if the provider were to terminate records. However, the Commission proposes to delete the requirement that the custodian be located in the Commonwealth. The Committee requests an explanation as to how the Commission would be able to gain access to these records if the custodian is located in another jurisdiction.

The Committee voted to take no formal action on Regulation 16A-489, Proposed Rulemaking of the State Board of Funeral Directors pertaining to continuing education, until final form regulations are promulgated.

The Committee voted to approve Regulation 16A-417, Final Rulemaking of the State Architects Licensure Board pertaining to firm practice.

The Committee voted to approve Regulation 16A-5714, Final Rulemaking of the State Board of Veterinary Medicine pertaining to continuing education provider appeal.

The Committee voted to approve Regulation 16A-4811, Final Rulemaking of the State Board of Funeral Directors pertaining to renewal fee.

The Committee voted to take no formal action on Regulation 16A-426, Proposed Rulemaking of the State Board of Barber Examiners pertaining to barber schools until final form regulations are promulgated.
