Dear Chairman McGinley:

I am writing to inform you that the House Professional Licensure Committee held a meeting on January 27, 2004 on the following:

Regulation **16A-5117** – Final Rulemaking of the State Board of Nursing pertaining to continuing education for Certified Registered Nurse Practitioners was withdrawn by the Board in order to make clarifications suggested by IRRC.

The Committee voted to approve Regulation **16A-529** – Final Rulemaking of the State Board of Optometry pertaining to continuing education.

The Committee voted to approve **Regulation 16A-425** – Final Rulemaking of the State Board of Barber Examiners pertaining to deletion of examination fees.

The Committee voted to take no formal action on **Regulation 16A-6510** – Proposed Rulemaking of the State Board of Physical Therapy pertaining to Certificate of Authorization to practice without referral until final form regulations are promulgated. However, the Committee submits the following comments:

- The Committee notes the comments submitted by the Pennsylvania Physical Therapy
 Association (PPTA) relevant to the Board's definition of "continuous practice" as a
 minimum of 200 hours each year in the delivery of direct patient care. The Committee
 asks if the Board has given consideration to the concerns of the PPTA that this
 standard would disqualify otherwise qualified licensees who are currently practicing in
 management, research or academic settings from obtaining certificates of
 authorization.
- 2. The Committee notes the comments submitted by the Pennsylvania Medical Society (PMS) regarding the omission of statutory language pertaining to the prohibition against treatment of certain conditions, and language outlining the standards for referral to a licensed physician or other appropriate health care provider. The Committee asks if the Board has given consideration to the concerns raised by the PMS in that regard.
