The regulation corrects the official text of the Board's schedule of fees. A line was inadvertently dropped from the fee schedule when it was amended in 2001. This corrective amendment restores the line that was dropped and clarifies that the application fee for auction house or auction company is \$50 and the biennial renewal fee for auction house and auction company is \$200.

(9) State the statutory authority for the regulation and any relevant state or federal court decisions.

Section 6(a) of the Auctioneer and Auction Licensing Act (act)(63 P.S. § 7.34(a)) requires the Board to establish fees by regulation. This corrective amendment to the fee schedule is authorized under 45 Pa.C.S. § 901 and the regulations promulgated thereunder at 1 Pa. Code § 5.1(a)(relating to official text of published documents).

(10) Is the regulation mandated by any federal or state law or court order, or federal regulation? If yes, cite the specific law, case or regulation, and any deadlines for action.

The regulation is not mandated by any federal or state law, court order or federal regulation.

(11) Explain the compelling public interest that justifies the regulation. What is the problem it addresses?

The corrective amendment corrects the official text of the Board's schedule of fees relating to the application fee for auction house and auction company and the biennial renewal fee for auction house and auction company. These fees were originally promulgated in 1998 at \$50 and \$200 respectively. A line was inadvertently dropped from the fee schedule when it was amended in 2001, resulting in the error in the fee schedule as it currently appears in the Pennsylvania Code.

(12) State the public health, safety, environmental or general welfare risks associated with nonregulation.

The regulated community will be unclear as to the correct fees.

(13) Describe who will benefit from the regulation. (Quantify the benefits as completely as possible and approximate the number of people who will benefit.)

Applicants for initial licensure as an auction house or auction company and current licensees who renew their licenses will benefit as the official text does not contain accurate information as to the required fees as adopted by the Board.

(14) Describe who will be adversely affected by the regulation. (Quantify the adverse effects as completely as possible and approximate the number of people who will be adversely affected.)

The Board had identified no groups or individuals who will be adversely affected by the regulation, as it is merely correcting an error in the text of the Board's schedule of fees.

(15) List the persons, groups or entities that will be required to comply with the regulation. (Approximate the number of people who will be required to comply.)

All applicants for initial licensure as an auction house or auction company and all currently licensed auction houses and auction companies will be required to comply with the regulation.

(16) Describe the communications with and input from the public in the development and drafting of the regulation. List the persons and/or groups who were involved, if applicable.

No input from the public was sought in the development and drafting of this corrective amendment. Public input was obtained in 1998 when the fees were originally promulgated. See 28 Pa.B. 1559.

(17) Provide a specific estimate of the costs and/or savings to the regulated community associated with compliance, including any legal, accounting or consulting procedures which may be required.

No specific costs or savings to the regulated community are anticipated. The regulation merely corrects the official text of the Board's regulations relating to its schedule of fees.

There are no anticipated costs or savings to local government associated with this regulation.

No alternative nonregulatory schemes were considered.

The regulation does not affect any other existing or proposed regulations of the Board or other state agencies.

The regulation does not change any existing reporting, record keeping or other paperwork requirements.

PREAMBLE

The State Board of Auctioneer Examiners (Board) amends § 1.41 (relating to schedule of fees) to read as set forth in Annex A.

Omission of Proposed Rulemaking

Under authority of section 204(3) of the act of July 31, 1968 (P.L. 769, No. 240) (known as the Commonwealth Documents Law) (CDL) (45 P.S. § 1204(3)), the Board has omitted the procedures for proposed rulemaking set forth in sections 201 and 202 of the CDL (45 P.S. §§ 1201 and 1202). Proposed rulemaking has been omitted because public comment is unnecessary in that this amendment merely corrects the Board's fee schedule to replace a line that was inadvertently dropped when the section was amended in 2001, and because public comment on the fees was provided at the time they were originally adopted in 1998. Additionally, 45 Pa.C.S. §901 (relating to official text of published documents) and regulations of the Legislative Reference Bureau (LRB) at 1 Pa. Code § 5.1 (relating to official text of published documents) provide that if an agency discovers a discrepancy between the agency text and the official text of a document, the agency shall deposit with the LRB, without regard to the requirements relating to notice of proposed rulemaking and adoption of regulations, an appropriate corrective amendment to the official text.

Description of Final-Omitted Rulemaking

Section 1.41 is amended to clarify that the application fee for auction house and auction company is \$50 and that the fee for biennial renewal for auction house and auction company is \$200 as originally established by the Board in 1998. The 2001 amendments to § 1.41 were not intended to change these fees. At that time, a line was inadvertently dropped from the original language of this section resulting in the inaccurate fees that appear in the official text.

Background and Need for Amendment

Section 1.41 was added to this Chapter in 1998, when the Board restructured its regulations to provide a section where all fees would be conveniently located. As proposed on March 28, 1998, the application fee for auction house and auction company was \$50 and the biennial renewal fee for auction house and auction company was \$200. See 28 Pa.B. 1559. The fees were adopted as final rulemaking on November 28, 1998. See 28 Pa.B. 5869.

When the Board adopted amendments to § 1.41 in 2001, a line was inadvertently dropped from the fee schedule. See Pa.B. 6941. The error resulted in the application fee for auction house and auction company appearing as \$200 in the final rulemaking and the biennial renewal fee for auction house and auction company was dropped completely. The final rulemaking of December 22, 2001, was intended to add additional fees to the

fee schedule. The Board did not intend to make any changes to the existing fees at that time. This rulemaking corrects the fee schedule to include the fees as they were originally adopted and as approved by the Independent Regulatory Review Commission, the House Professional Licensure Committee and the Senate Consumer Protection and Professional Licensure Committee.

Effective date

As permitted under 1 Pa. Code § 5.1(a), the amendment shall be effective retroactively to the date of the defective official text, December 22, 2001.

Statutory Authority

Section 6(a) of the Auctioneer and Auction Licensing Act (63 P.S. § 734.6(a)) requires the Board to establish fees by regulation. This corrective amendment is authorized under 45 Pa.C.S. § 901 and the regulations promulgated thereunder at 1 Pa. Code § 5.1(a)(relating to official text of published documents).

Fiscal Impact and Paperwork Requirements

The final-omitted rulemaking is expected to have no fiscal impact as it merely corrects the official text of the Board's schedule of fees as originally intended. It also imposes no additional paperwork requirements on the Board, the regulated community or the public.

Regulatory Review

Under section 5.1(c) of the Regulatory Review Act (71 P.S. § 745.5a(c)), the Board submitted a copy of the regulation with proposed rulemaking omitted on January 30, 2006 to the Independent Regulatory Review Commission (IRRC), the Senate Consumer Protection and Professional Licensure Committee (SCP/PLC), and the House Professional Licensure Committee (HPLC). On the same date, the regulation was submitted to the Office of Attorney General for review and approval under the Commonwealth Attorneys Act (71 P.S. §§ 732-101 – 732-506).

In accordance with section 5.1(j.2) of the Act (71 P.S. § 745.5a(j.2)), the regulation was (deemed) approved by HPLC on ______ 2006 and (deemed) approved by SCP/PLC on ______ 2006. Under section 5.1(e) of the Act (71 P.S. §745.5a(e)), IRRC met on ______ 2006 and (deemed) the regulation approved.

Findings

The State Board of Auctioneer Examiners finds that:

(1) Public notice of the Board's intention to amend its regulations as adopted by this order, under the procedures specified in sections 201 and 202 of the Commonwealth Documents Law (CDL) (45 P.S. §§ 1201 and 1202), has been omitted under the authority contained in Section 204(c) of the CDL (45 P.S. § 1204(3)), because the Board has, for good cause, found that the procedures specified in Sections 201 and 202 of the CDL are in this circumstance, unnecessary because the rulemaking corrects an inadvertent error in the official text of the Board's schedule of fees and because public comment was provided at the time the fees were originally adopted in 1998.

(2) The amendment of the regulations of the Board in the manner provided in this order is necessary and appropriate for administering the Auctioneer and Auction Licensing Act.

Order

The State Board of Auctioneer Examiners, acting under the Auctioneer and Auction Licensing Act, orders that:

(a) The regulations of the Board, 49 Pa. Code Chapter 1, are amended by amending § 1.41 (relating to schedule of fees) to read as set forth in Annex A.

(b) The Board shall submit this order and Annex A to the Office of General Counsel and the Office of Attorney General for approval as to form and legality as required by law.

(c) The Board shall certify this order and the attached Annex A and deposit them with the Legislative Reference Bureau as required by law.

(d) This order shall become effective immediately upon publication in the *Pennsylvania Bulletin*.
