We submit for your consideration the following comments on the proposed rulemaking published in the August 26, 2006 *Pennsylvania Bulletin*. Our comments are based on criteria in Section 5.2 of the Regulatory Review Act (71 P.S. § 745.5b). Section 5.1(a) of the Regulatory Review Act (71 P.S. § 745.5a(a)) directs the State Employees' Retirement Board (SERB) to respond to all comments received from us or any other source.

1. Section 250.2. Appeal Period from decisions of administrative staff. – Clarity. This section states: "Decisions of administrative staff under authority delegated by the [State Employees' Retirement] Board may be appealed to the Board by filing a formal appeal within 30 days after service of notice of the administrative decision...." The General Rules of Administrative Practice and Procedure provides for only a 10-day appeal period (1 Pa. Code § 35.20). In order to reduce the likelihood of confusion and also to provide consistency with the format in Subchapter B, the SERB should include a paragraph (b) which clarifies that this section supersedes 1 Pa. Code § 35.20.
