Dear Ms. Bender:

I have lived in Bucks County, Pennsylvania on a farm since September, 1965. I have had numerous dogs, horses and cats since that time. I am a farmer and in those forty years, I have belonged to numerous clubs and organizations including AKC kennel clubs, MFH fox hunting clubs and the US Pony Club. I have been involved in many different aspects of dog ownership including breed, obedience, tracking, and field work. I am presently a member of the Bucks County Horse Park and the Irish Water Spaniel Club of America. I have a stud dog presently that I use in breeding programs and a Labrador Retriever which I run in field trials up and down the East Coast. I am a responsible dog owner and have always been.

I am distressed at the turn of events that has befallen the dog world in the past 40 years. I have followed the legislation and the agenda of "animal rights groups" and I believe it is to the detriment of all of us to allow a radical group to become involved and have influence on our politicians.

Most of all, I am so disappointed in Gov. Rendell who I actually voted for in November. If I had realized that PA was still talking about PAWS type legislation, I would never have voted for him.
