INDEPENDENT REGULATORY REVIEW COMMISSION

I am a responsible pet-quality dog breeders which means that I have a few litters of puppies, now and then. I do this strictly as a hobby and am a nuturing and person who desires excellence both in health issues as well as temperament and family-friendly puppies.

I am writing to comment on proposed amendments to PA dog law regulations issued on December 16,2006. I believe that any inhumane and substandard kennel conditions should not be tolerated, but I do not agree that most of the propose regulatory changes are needed, or would necessarily have a beneficial outcome if adopted Many are impractical, excessively burdensome and costly, unenforceable, and/ or will not improve the quality of life for the dogs in these kennels.
