RE: No. 2583 State Board of Education #6-303: Certification of Professional Personnel (Chapter 49)

To the Members of the State Board of Education and the Independent Regulatory Review Commission:

The Education Law Center (ELC) encourages the Independent Regulatory Review Commission to approve the final form revisions to Chapter 49.

The Chapter 49 changes in teacher preparation and professional development are necessary for the Commonwealth to meet its legal obligations under existing state and federal laws. Improving teacher knowledge and skills for diverse learners will allow compliance with the mandates of the No Child Left Behind Act of 2001 (NCLB) and with State academic and assessment standards.

The State Board developed these regulations through an excellent process of engaging stakeholders in addressing real classroom needs. ELC believes that children, teachers, and schools will benefit from the new provisions. ELC did not get everything we asked for in this round of policy development, but we respect the judgment of the State Board and will work for additional reforms in the future.

Prompt approval of these regulations by IRRC will help to ensure that all educators can meet the highest expectations for student achievement, teacher quality, and school performance. ELC will continue working with the State Board to further strengthen the rules for teacher certification to ensure that all students have access to highly qualified teachers and a quality public education.
