Thank you for taking the time to e-mail me recently regarding your opposition to regulation 49.13(b)(4)(i). As you know, this is a regulation regarding the training requirements of the Commonwealth's teachers. Specifically, it will require all Pennsylvania-certified education students to pass nine credits worth of classes that focus on preparing them to teach students with special needs. I appreciate your concerns that this will cause a much higher course load and may force students to sacrifice other important classes in order to graduate in a reasonable time.

This proposal is currently pending before the State Board of Education. Unfortunately, as a State Representative, I do not have jurisdiction over this proposed regulation. The Board will, however, be accepting comment from the public until December 25, 2006. Regarding 49.13(b)(4)(i), I would like to urge you to vote no. As a student of music education, I recommend that no more than 90 hours (equivalent of 3 credits) for instruction in literacy skills development and cognitive skill development for students with disabilities be addressed in the initial certification program and the remaining hours plus the 90 hours for English language learners be requirements for Instructional II certificates.
