State Board of Examiners of Nursing Home  
Administrators  
Administrator-In-Training Program

On March 28, 2007, the Independent Regulatory Review Commission (Commission) received this proposed regulation from the State Board of Examiners of Nursing Home Administrators (Board). This rulemaking amends 49 Pa. Code Chapter 39. The proposed regulation was published in the April 7, 2007 *Pennsylvania Bulletin* with a 30-day public comment period. The final-form regulation was submitted to the Commission on April 28, 2008.

This final-form regulation establishes an administrator-in-training program for candidates who wish to sit for the nursing home administrator examination, but do not have the experience currently required to qualify.

We have determined this regulation is consistent with the statutory authority of the Board (63 P.S. §§ 1104(a)(1) and (c)) and the intention of the General Assembly. Having considered all of the other criteria of the Regulatory Review Act, we find promulgation of this regulation is in the public interest.
