Re: IGT Comments regarding 58 PA Code Chapter 429a relating to manufacturer designees

Dear Mr. Resch:

On behalf of International Game Technology ("IGT") and its subsidiaries, we would like to thank the Pennsylvania Gaming Control Board (the "Board") for the opportunity to comment on the proposed rules and respectfully request the Board take into account the following suggestions.

IGT has one observation regarding Chapter 429a (relating to manufacturer designees) created by the Act of November 1, 2006 (P.L. 1243, No 135). The term of "manufacturer designee" was never defined in the Act under section 1317.1 manufacturer licenses. In section 1317.1(d.1)(1) of the Act it states that 'A licensed manufacturer or its designee, as licensed by the board, may supply or repair any slot machine or associated equipment manufacturer by the licensed manufacturer.' The term "manufacturer designee" is not clearly defined in this section. In section 1103 under definitions of the Act the phrase is not listed as a defined term either. IGT recognizes the statute cannot be changed to define the term at this time; however IGT respectfully recommends this term be defined clearly in Chapter 429a and in Chapter 401 under definitions.
