The Arc of Pennsylvania has been a strong proponent of the open forum of roundtables and public comment opportunities and applauds the efforts to reform the Pa. Code 22-Chapter 14 regulations. The Arc of PA has a 59 year history in advocating for the rights of citizens with cognitive, intellectual and developmental disabilities. We are especially proud of our efforts in the educational right of children with disabilities, through our leadership in the PARC Consent and Gaskins Settlement.

The Arc testified before the State Board of Education numerous times and was active in a coalition of organizations- VALUE, that pushed for many of the proposed reforms. We are pleased with many of the reforms, especially the addition of specific language, that references Oberti on least restrictive environment that will now clarify in the regulations how inclusion is to be applied to all children in meeting their educational needs. We were strong advocates for the reforms made to the Behavior Support section-14.133- that eliminates the use of prone restraints, as well as the emphasis on the use of positive supports and interventions. This will promote and foster greater protection from abuse and protect the physical, as well as emotional safety of all of Pennsylvania's children. . Although not all of The Arc of PA's suggestions were accepted, we appreciate that our suggestions were heard and valued throughout the process.

The Arc of Pennsylvania and the local chapters of The Arc work in partnership every day to carry out our mission- to work to include all children and adults with cognitive, intellectual and developmental disabilities in every community.

We encourage the Commission to accept the final form for 22 PA Code Chapter 14, Special Education Services and Programs. Thank you for the opportunity to comment on the issues and to have played a contributing role in the development of these significant reforms to Chapter 14, that is most important to the children and families for whom we advocate.
