I oppose proposed regulation 16A-4816, IRRC # 2639 for, among others, the following reasons:

These proposed regulations are an attempt to circumvent and ignore the federal court case, *Walker V. Fittion (2005)*. There has been no public outcry or harm to a consumer that would demand such strict regulations.

The passing of these regulations will chill competition in Pennsylvania.
