National Guardian Life Insurance Company appreciates the opportunity to comment on the above referenced proposed rules regarding the activities of unlicensed persons proposed by the Pennsylvania State Board of Funeral Directors.

NGL is opposed to this regulation for the reasons set forth in the submissions of both Forethought Financial Group and Assurant Solutions. NGL concurs in their comments.

NGL believes that the Pennsylvania State Board of Funeral Directors has not demonstrated a need for the regulation. To illustrate this fact, in their submission to the IRRC, the Pennsylvania State Board of Funeral Directors indicates that the regulation is not based upon any scientific data, studies or references.
