Regulation No. 16A-5420 (#2663) State Board of Pharmacy Pharmacist Breaks

On January 9, 2008, the Independent Regulatory Review Commission (Commission) received this proposed regulation from the State Board of Pharmacy (Board). This rulemaking amends 49 Pa. Code Chapter 27. The proposed regulation was published in the January 19, 2008 *Pennsylvania Bulletin* with a 30-day public comment period. The final-form regulation was submitted to the Commission on September 28, 2009.

This regulation amends the Board's rules pertaining to pharmacist breaks. It allows a sole pharmacist on duty to take up to a 30-minute break while remaining in the immediate building.

We have determined this regulation is consistent with the statutory authority of the Board (63 P.S. §§ 390-4(j), 390-6(k)(1) and 390-6(k)(9)) and the intention of the General Assembly. Having considered all of the other criteria of the Regulatory Review Act, we find promulgation of this regulation is in the public interest.
