Dear Mr. Kaufman:

The House Professional Licensure Committee on this date voted to take no formal action on Regulation 16A-629 until final regulation is promulgated and submit the following comments:

1. The committee suggests a technical change in the definition section. The definition for temporary permit "authorizes a person." Person, as defined in the statutory construction act would include a corporation, LLC, etc. The committee suggests that the definition read "A permit issued by the Board authorizing an individual...".

- The committee requests elaboration on the reasoning for §39.4 (3)(ii). What is the reasoning for not wanting the temporary permit holder to be qualified or eligible to sit for the exam? The committee understands the language to mean that merely because one holds a temporary permit, they are not automatically qualified to sit for the licensing examination. However, the committee believes it would be beneficial for an individual holding a temporary permit to be otherwise qualified to be a nursing home administrator. The statute states that a temporary permit holder must meet certain criteria, including "suitability as provided in this act," however that phrase is left open to interpretation and there is no requirement stating that a temporary permit holder must comply with any part of the education or experience requirements.
- 3. The committee also suggests that in Section 39.17(b) the Board delete the first sentence. The first sentence may be unnecessary as any applicant for licensure as an administrator would need to demonstrate suitability as a candidate to the board. It is implicit that such time in the position of a temporary permit holder would not "count" as anything else.
