Although the Keystone Exams will not correct all the issues that currently exist, I believe they are a step in the right direction.

My company, JIT Tool and Die, is located in Elk County and employs 50 people, and we manufacture high-end tooling primarily for the metal powder industry in and around the north central Pennsylvania region. As you may know, manufacturing accounts for 35% of all jobs in our rural area and plays an important in the national economy as well as the local Pennsylvania economy.

I am a product of our Pennsylvania education system as is my wife and my five children. I strongly believe that we have good schools, skilled teachers and a progressive educational system. However, as in my business and every day life, things are changing all around us. Like it or not, we have all had to change. Business as usual is no longer the accepted norm. We have all been squeezed into a mold of change by global demands of the 21st century and we all need to respond and respond quickly. If we are to survive in manufacturing, we must strive to prepare a highly skilled work force and the foundation for that is a sound school education.

Unfortunately, at the present time, a Pennsylvania high school diploma does not ensure anyone that the graduate is prepared to move on. Many graduates find only frustration when told that their competency levels are not sufficient to either start their employment or their higher education future. Many industries, as well as universities, colleges and training schools are finding it necessary to remediate recent graduates.
