On September 10, 2009, we introduced House Resolution 456, in response to the request of many educational advocates, to prevent any further action or taxpayer dollars being spent on new high school graduation requirements. As you are aware, there is strong opposition to these proposed Keystone Exams, and we believe that these tests should not move forward until the concerns of the Legislature and our constituents have been addressed.

HR 456 has overwhelming support - currently cosponsored by **147** House Members. The Resolution was drafted with input from individual school board members, teachers, parents, grassroots volunteers and Members of the General Assembly – a true reflection of an open and democratic process.

The Resolution will ensure that we have the opportunity to represent the people who elected us and will allow us to fulfill our responsibilities as set forth in the Pennsylvania Constitution. The Governor has recognized that solutions to education policies and funding issues "must come from the lawmakers and the democratic pressures of those who elect them" in past court filings.

Furthermore, at a time when Pennsylvania is facing the worst economic times since the Great Depression, it is not fiscally responsible to expend hundreds of millions in taxpayer dollars for the implementation of an initiative with so many unanswered questions and legitimate concerns.
