Dear Ms. Steffanic:

The National Association of Clinical Nurse Specialists (NACNS) represents the interests of over 72,000 Clinical Nurse Specialists (CNSs) in the United States. NACNS appreciates the opportunity to offer comments on behalf of our PA members regarding proposed Regulation #16A-5133 (Clinical Nurse Specialists).

Our recommendations are intended to clarify the language of the regulations, but not to modify the intent. In addition we have offered some comments that pertain to the administrative aspects of these regulations.

Comments on the Preamble

Revise the language of the third example that pertains to ANCC certified CNSs who have a bachelor's degree in nursing and a master's degree in psychology. For clarity, we recommend this substitution: Third, the nurse holds a current national certification as a Clinical Nurse Specialist from the American Nurses Credentialing Center (ANCC), having been initially certified at a time when ANCC offered certification to nurses who held a bachelor's degree in nursing and a master's degree in a related specialty.

<u>Board</u> rather than use the term "Approved" to indicate that the Board accepts or recognizes a program or a certifying body, etc.

Eliminate <u>approved program</u> and substitute <u>accepted</u> for those programs that the Board recognizes.

Use "approved" to indicate Board approval of PA offerings.

Subsection (1)(i)

Line 5: Substitute the <u>National Organization for Competency Assurance</u> (NOCA) in place of the National Council of State Boards of Nursing (NCSBN).

Rationale: ABNS and NOCA are the recognized accreditors of nursing certification agencies. NCSBN is the membership association for State Boards of Nursing, and as such, is not in a position to set standards for or accredit of nursing certification agencies.

- (B) delete original and add For a CNS who is not eligible to take a National Certification examination in the CNS specialty area or in an area that encompasses the CNS specialty area, the CNS may demonstrate eligibility through validation by a Board accepted national nursing, nursing specialty or credentialing organization within the past three years or recertification if the certification or other process occurred more than three years ago.
 - (C) Add A CNS may demonstrate eligibility by submitting the appropriate document(s) and fees to a Pennsylvania approved CNS program for review and critique. The review and full critique shall be submitted directly to the Board as well as to the applicant.

Subsection (d)(1) Add: If an applicant is unable to obtain an official transcript and verification of the degree awarded and course work in the specialty from the CNS program, the Board will accept reasonable alternative or equivalent verification such as the school bulletin, records provided by a classmate, records provided by the state board of nursing in the state where the program was offered.

Rationale: This accounts for circumstances in which a program has closed or records have been destroyed.

Specify that a nurse will be eligible to apply for Board certification as a CNS for two years after the final publication of these regulations
