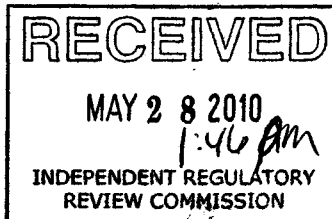

RE: Assisted Living Residences, DPW Final-Form Regulation #14-514 (#2712)

Dear Mr. Coccodrilli:

I am writing on behalf of CARIE, the Center for Advocacy for the Rights and Interests of the Elderly, to request that the Independent Regulatory Review Commission (IRRC) approve the Assisted Living Residences, DPW Final Form Regulation #14-514 (#2712) scheduled for a vote on June 3, 2010. CARIE is a non-profit organization dedicated to improving the quality of life for frail older adults by working to protect their rights and promote awareness of their needs and concerns. CARIE provides long term care ombudsman services to residents in about 150 nursing facilities and personal care homes in north, west, south and central Philadelphia so we understand the impact these regulations will have on consumers.

While we are supportive of the regulations being approved, we still have numerous concerns that are documented in the comments submitted during the proposed rulemaking stage as well as those identified by the Pennsylvania Assisted Living Consumer Alliance (PALCA). Some concerns relate to inherent flaws in Act 56 of 2007 that we understand can not be adequately addressed in the final regulations such as the informed consent process, the lack of appeal rights for residents, and the limitations a residence may place on who can provide health or supplemental health care services. Other issues related to the health and welfare of residents also fall short in the final regulations. For example, the regulations should better reflect higher staffing and training standards to ensure quality care in assisted living residences. We are also still concerned about the role of the ombudsman in the informed consent process involving "incompetent" residents.

However, overall we do believe that the final form regulations will offer residents a better standard of care than available in a personal care home as well as the framework to provide residents the opportunity to "age in place." CARIE is also particularly pleased to see the clear concise delineation of resident rights as outlined in Appendix A. This list will serve as an important tool in educating residents and their families about their rights.

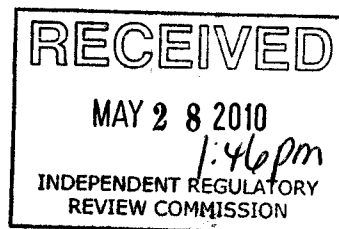
