

Dear Kate,

I am a nursing home administrator in the Lansdale area and resident of Blue Bell. I need to bring to your attention my concerns with the proposed legislation to establish regulation and impose barriers to access for the assisted living.

I am very upset with PA taking ownership of the name assisted living and under the guise of making MA dollars available, establishing a third regulatory enviornment and care environment that only serves to break the back of the industry and prevent seniors from getting needed care.

As drafted the new regulations will prevent the majority current providers from being licensed, and without revision few providers will choose to be licensed as 'Assisted Living Residences' This is because the regulation will make 'Assisted Living Residences' so costly (estimates have ranged from \$4,500-\$7,000/month depending upon region) that low and moderate income Pennsylvanians will not be able to afford or access this care.

Some of the significant cost increases in this legislation are over extensive square footage requirements and licensure fees that would change from \$50 for a 100 bed unit to \$11,000.

The regulations also call for significant changes in staffing supposedly aimed to manage a higher acquity level, however, requirements are beyond current levels for a skilled care residence.

Additionally, the inability to carry a dual licensed status for Assisted Living and Personal Care beds flaws a system that will require us to have either all lower cost person care beds or all higher cost assisted living beds. Once again leaving out a large segment of PA's neeedful population.

Please help us to defeat this proposed regulation and urge them to do their homework first. The appropriate studies and right legislation will help to define this new level of care and provide benefit to all segments of the population.
