As PALA indicated in the previous email/fax, the Assisted Living Residence Regulations 2800 are posted in the PA Bulletin. The Office of Long Term Living (OLTL) is accepting your comments and inquiries until September 15, 2008. You must send your comments via hard copy to OLTL and we suggest a copy be sent to the Independent Regulatory Review Commission (IRRC) simultaneously. The OLTL must respond to each comment or question they receive.

Due to a publication error on the part of DPW, the public comment period is extended to September 15, 2008, but PALA recommends you send your comments in ASAP! PALA would appreciate a copy of your comments and issues with ALR 2800 also.

Whether you are considering ALR Licensure or cannot meet or lack interest in being licensed under the ALR regulations, please take the time to complete this survey. Your comments will help us deliver a strong message to IRRC and the Standing Committees on the major fatal flaws we have found in relationship to the 2800 Regulations. We need to hear from you!

### 2800.11 Procedural requirements for licensure or approval of ALR

- A \$500 license application or renewal fee (1)
- A \$105 per bed fee that may be adjusted by the Department annually at a rate not to exceed the consumer price index. The Department shall publish a notice in the PA Bulletin when the per bed fee is increased.

The residence must at a minimum, provide the following services:</li> <li>(1) Meals and snacks</li> <li>(2) Laundry services</li> <li>(3) Social and recreational activities</li> <li>(4) Assistance with performing ADL's and IADL's</li> <li>(5) Assistance with self-administration of medication or medication administration as indicated in the resident's assessment and support plan</li> <li>(6) Household services</li> <li>(7) Transportation</li> </ul> </li> </ul>
This fee schedule and bundling of Core Service is open for interpretation as written. The question remains as to whether the fee schedule for services and accompanying charges for the services to the resident will be permitted. It does not address if the
