Subject: Proposed rulemaking-sale of liquor by vendors

Thank-you, Lynn, for agreeing to answer my questions regarding the proposed rulemaking published in the PA Bulletin on August 23 regarding the sale of liquor by vendors.

MeeCee Baker asked me to look over these regulations and give her a summary before tomorrow's meeting with our client, the Pennsylvania Winery Association.

I understand the genesis of the regulation and the Board's desire to open the accessibility of rare wines to the public through the wine and spirits stores while still allowing the vendors and their agents to continue to offer them, as they currently do, to private citizens and Board licensees (restaurants) as a niche market. I have a question about restrictions on page four. Item (e) proposes that vendors and their agents place luxury item order at the State Liquor Stores. Is this for tracking purposes as in the previous paragraph 13.77 which proposes but then deletes a quadruplicate filing process? In other words, can these items still be ordered and shipped directly from the vendor/agent or must they be ordered at the wine and spirits stores?
