I am writing to voice my opposition to the Dental Hygiene Scope of Practice Final-Form Regulation IRRC #2720.

My particular complaint involves the centralization of dental hygienists to administer drugs by injection i.e. local anesthesia. This is <u>NOT</u> a benign procedure. It requires extensive clinical and didactic training to deliver safely. The amount of training in the regulation, especially for individuals that have only a high school education plus a hygiene course, is totally inadequate. The heart of this question is patient safety and nothing else. All special interest agendas do not supersede patient welfare and protection.

I have been a board certified Oral and Maxillofacial surgeon for over thirty-five years. I was n American Board of Oral and Maxillofacial Surgery Examiner for six years. I have seen many untoward results and reactions from local anesthesia. They can be life threatening in the extreme.
