SUBJECT: DENTAL HYGIENE SCOPE OF PRACTICE FINAL-FORM REGULATION, IRRC #2720

Dear Mr. Coccodrilli:

I have served on the Pennsylvania State Dental Board for thirteen years and was chairperson for ten consecutive years.

My comments are directed at the Dental Hyglene Scope of Practice Final-Form regulation IRRC #2720.

It is my opinion that the State Board of Dentistry does not have the authority to grant the dental hygienist the privilege to administer local anesthesia, both infiltration and block. I will leave this matter to the legal profession since I am not a lawyer.

More importantly, the dental hygienist does not have the necessary education to administer local infiltration and local block anesthesia. They do not have a sufficient educational background in a two year technical education where at least one of the two years is devoted to cleaning teeth.

The hygienist does not have an adequate background in Pharmacology, which would have them understand the make-up and use of drugs.

They do not have adequate training in Physiology which would teach them how the drugs interact on the entire body.

They do not have an adequate amount of training in Anatomy which would teach them where to inject the drug and what they must avoid. Catastrophic events may occur if the drug is injected in the wrong place.

They do not have adequate courses in Medicine, which would teach them who should and who should not receive which type of anesthesia.

They do not have adequate course knowledge in Microbiology which would teach them the techniques of safe bacterial and viral contamination.

As you can readily see, local anesthesia requires an extensive amount of academic background in the basic sciences. This is impossible to obtain in their basic training. It is equally absurd to think that thirty hours of "anesthesia training" is adequate.

I would not allow a dental hygienist to inject me or my family and they should not be allowed to inject dental patients. This is a protection of the public issue.

It is not just sticking someone with a needle; anyone can be shown how to do that. It is the extensive medical background information and training that is needed and necessary.

I urge the IRRC not to allow this to pass and to protect the citizens of the Commonwealth. They deserve better.

This regulation has no effect on the access to care issue.
