To Whom It May Concern:

I am writing in support of new regulations expanding the practice of Nurse Practitioners in Pennsylvania. I have practiced as a CRNP in the state of Pennsylvania for over 23 years. During that time, I have seen positive changes to our scope of practice, but I believe the proposed regulations will improve access to health care for Pennsylvanians while becoming more consistent with the expanded scope of practice authorized by Act 48.

The removal of the 4:1 NP to Physician ratio would improve access to care as there are fewer physicians to collaborate. I have the good fortune to be in a practice that this is not a problem but many of my colleagues in rural and center city clinics are restricted. This will become more problematic as only 2-3 % of new physicians are entering family practice.

The schedule II, III and IV drug prescriptions hamper my care to patients with chronic pain, especially in my geriatric practice. There are frequently occasions when I can only provide patients with a short supply of the medications when I am on-call or in the office alone. Sometimes this also creates a more costly alternative to patients seeking a 90 day supply of pain meds.

With the goal of improving access to health care, approval of these Rules and Regulations will provide another step to improving healthcare for the residents of Pennsylvania.
