

As discussed in our exchange of telephone messages June 30, I am writing to confirm a typographical error in the transmittal sheet for the referenced final rulemaking.

On June 25, 2010, we delivered the referenced final rulemaking of the Commissioner of Professional and Occupational Affairs. The transmittal sheet indicates that the rulemaking is to be delivered to the House Committee on State Government and the Senate Committee on State Government. These are typographical errors. The rulemaking was supposed to be and was in fact delivered to the House Professional Licensure Committee (Michael P. McGeehan, chair) and the Senate Consumer Protection and Professional Licensure Committee (Robert M. Tomlinson, chair). The names of the committee chairs are correct on the transmittal sheet.


