Public Comment Period Extension - Proposed "Administration of the Water and Wastewater Systems Operator's Certification Program" Regulations

In light of an error that occurred with the publication of the proposed "Administration of the Water and Wastewater Systems Operator's Certification Program" regulations in the *PA Bulletin* at 39 Pa.B. 3591 < see <http://www.pabulletin.com/secure/data/vol39/39-28/1272.html>>, please be advised that DEP has extended the public comment period for the proposed rulemaking by an additional 30 days to September 9, 2009. In the PA Bulletin notice on the proposed rulemaking, which was published on July 11, 2009, an incorrect e-mail address was listed for the EQB.

Interested persons are invited to submit comments, suggestions or objections regarding the proposed rulemaking to the EQB, P.O. Box 8477, Harrisburg, PA 17105-8477 (express mail: Rachel Carson State Office Building, 16th Floor, 400 Market Street, Harrisburg, PA 17101-2301). Comments submitted by facsimile will not be accepted. The Board must receive any comments, suggestions or objections by September 9, 2009. Interested persons may also submit a summary of their comments to the Board. The summary may not exceed one page in length and must also be received by September 9, 2009. The one-page summary will be provided to each member of the Board in the agenda packet distributed prior to the meeting at which the final regulation will be considered. Comments may also be submitted electronically to the Board at **RegComments @state.pa.us** and must also be received by the Board by September 9, 2009. A subject heading of the proposal and a return name and address must be included in each transmission. Notice extending the public comment deadline will be published in the August 22, 2009, edition of the *PA Bulletin*.
