Mr. Davenport. My principal concern is the proposed protracted process contained in Subchapter D, Sections 13.50 and 13.52 to document and address discrepancies discovered at LPG installations. I believe the regulation should be such that the Department has the authority to immediately place out-of-service deficient installations that impose an immediate adverse impact to the health, safety and welfare of the public, including emergency responders! In addition, the Department should be required to provide timely notification to the appropriate municipal officials that provide emergency response services to the location of all deficient installation, regardless if the installation is sealed or not by the Department. Each emergency responder deserves timely receipt of information that may affect their personal safety so that should a response occur to that location they will be sufficiently pre-warned so as to minimize potential personal harm to the greatest extent possible.
