Dear Mr. Hoge:

I write to express my concern that the time for comment on the proposed new Dairy Sanitary regulations is currently too short. At a time when there is much discussion about the need for transparency in government, we must not forget that to have true transparency, we must provide an adequate amount of time for reading the documents, discussing their implications and framing appropriate comments by those who will be most affected by these regulations. Thirty days for comment does not provide men and women who are working full time, often more than full time on their Pennsylvania dairy farm, to adequately consider and respond to PDA on an issue of this importance.

As a member of PASA, the Center for Food Safety and whose professional career included work with Pennsylvania legislators, I know a bit of how legislation works. I think that when legislative action or change by bureaus of government is considered, the list of shareholders is often too short and/or consideration of their concerns inadequate.

My primary concern is with Chapter 59a Milk Sanitation regulations and I am asking that the period for comment be extended for 90 days beginning with August 1, 2009. Such an extension is a more realistic time frame for affected persons to provide input and consequently provides a better opportunity for regulators to make wise choices.
