On behalf of the Pennsylvania Veterinary Medical Association (PVMA) and its 1,900 member veterinarians, I thank you for the opportunity to provide comments on the proposed rulemaking #16A-5723, Biennial renewal fees.

We have no objections to the biennial renewal fee increase as proposed in light of the past deficits and projected future deficits anticipated due to real expenditures surpassing the income brought in from licensure renewal fees. We realize that there have been deficits and the Board will continue to have deficits unless licensure renewal fees are increased is because of an increase in the number of complaints against veterinarians, particularly allegations of negligence or malpractice which require substantial resources to investigate, review, and prosecute. We also understand that the Board must be self-sufficient financially.

If there is anything we can do to help educate the veterinary profession and potentially help decrease the number of complaints and therefore, reduce the need to increase the licensure renewal fees in the future, please let us know. We welcome the opportunity to work with the State Board to ensure that the profession is as exemplary it can be which is also in the best interest of the clients and the patients the profession serves.
