SUBJECT: Outdoor wood-fired boilers- health vs. boilers

Honestly, it really shouldn't have to come to that because we should all be able to enjoy the outdoors and the fresh air that everyone else is entitled to. Also, I have lived in this same residence since 1954 and do not feel that I should have to move to escape the harmful pollutants.

Michael Vic went to prison for abusing dogs yet no one cares about the abuse innocent people are suffering by people contaminating the air and possibly jeopardizing their health and nothing seems to be done about it. Our government as well is guilty because we have to beg for help and it takes so long to be answered. I am 81 years old and had been in good health until an uncaring neighbor brought in these boilers not at all concerned about his neighbors and the effects using these boilers could have on their health.
