I do not think that your reaction to every piece of regulation should necessarily be negative since government has the responsibility to protect all natural resources including the air we breathe. Local governments generally do not have the knowledge or expertise to understand the complex issues related to pollution and therefore these regulations must come from the State or Federal Government. Everyone tends to forget that the only reason we have reasonably clean air to breathe every day is because of the significant regulation and control of most sources of pollution. Prior to those regulations the air in cities was extremely unhealthy and even out in the country toxic emissions created localized health problems.
