They have one of those outside heating units that should be checked out once. The chimney isn't more than a foot high there's no way it's 150' from two of his neighbors land. When he puts his wood or anything else in it the black smoke flies out all over all his neighbors. There's an 80 some year old beside them about 50' from her land then there's a man and woman in their 70's up from his furnace not to much more than 50 or 70 ft from their land. The lady in that place isn't in good health she had a heart attack a few years ago also has asthma and a lot of trouble breathing. She was at her doctor in Lykens for her breathing 2 times in one week, still has trouble breathing. That heating unit sure doesn't help. There are about 4 or 5 other homes above his who also get all the smoke. The lady with the

and the smoke he told that person
(it's my d-- land and i'll do as i

The lady with the breathing problem
was taken to the Harrisburg Hospital
ER by medic 6 for pain and trouble
breathing that was only the month of Nov.
still has problems. He is a very smart
hateful bad attitude man who thinks he
don't have to care about anyone else. For
this reason i can't give my name
i don't live close to him but i can
see all the black smoke this is one
person who should be put straight on
the law and use of that unit. He ~~has~~
has the junkiest looking ^{junk} around his
home its on RT 147 along the road.
Please check this man and that unit out, i
can't give my name but i know if you
