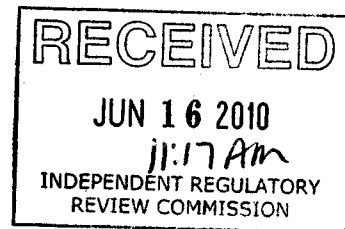

Dear Chairman Coccodrilli,

I am writing today to urge the IRRC approval of the following two EQB rule revisions:

First, I would like to indicate my support for the FEQB's revisions to the rules for Erosion and Sedimentation Controls (IRRC #2783, EQB 7-440). The revisions in question mandate a 150 foot buffer for new developments along streams rated as Exceptional Value and High Quality.

I would also like to indicate my support for the EQB's revisions to the rules for Wastewater discharge standards (IRRC #2806, EQB 7-446). As a cosponsor of House Bill 2213, which establishes well permitting requirements, well location restrictions and casing requirements, and disclosure and monitoring of hydraulic fracturing chemicals and surface impoundments, I support the discharge standards drafted by DEP and believe that the IRRC should approve EQB 7-440.
