First, I would like to indicate my support for the FEQB's revisions to the rules for Erosion and Sedimentation Controls (IRRC #2783, EQB 7-440). The revisions in question mandate a 150 foot buffer for new developments along streams rated as Exceptional Value and High Quality.

I would also like to indicate my support for the EQB's revisions to the rules for Wastewater discharge standards (IRRC #2806, EQB 7-446).
